
Written examinations for the recruitment of 126 posts (38 posts in General Recruitment & 88 posts in Special Recruitment) of Inspector of Coop. Societies by way of Selection.

In pursuance to the order dated 27.01.2017 of Hon'ble Odisha Administrative Tribunal, Cuttack in OA No.1484(C)/2012 (Lalatendu Rath & two others-vs- State of Odisha & others), OA No.1672 (C) /2012 (Pranaya Kumar Dash & another -vrs- State of Odisha & others), order dated 22.10.2019 of Hon'ble High Court of Orissa passed in WP(C) No-17472 of 2019 (Madan Mohan Parida -vrs- State of Odisha & others) and order dated 11.04.2023 of Hon'ble High Court of Orissa passed in WP(C) No-10417 of 2023 (Sunil Kumar Mohanty and another-vs-State of Odisha & others), the written examinations for the posts of Inspector of Cooperative Societies by way of Selection will be conducted at Bhubaneswar on 11.05.2025.

1. The notice was issued vide letter No-13735 dated 03.09.2022 to fill up the 38 posts of Inspector of Cooperative Societies in General Recruitment & vide letter No.13739 Dt.03.09.22 to fill up 88 posts of Inspector of Cooperative Societies in Special Recruitment.
2. Applications has been received from the candidates through the Divisional Deputy Registrar of Cooperative Societies.
3. The written Examination for the post of Inspector of Cooperative Societies by way of Selection have not been conducted so far due to certain unavoidable reasons and circumstances.
4. All the candidates are hereby informed that the written examinations for the said posts shall be conducted at Unit-I Boys High School Bhubaneswar on 11.05.2025.
5. As per Rule 11(1) of Odisha Sub-Ordinate Cooperative Service (Recruitment & Conditions of Service) Rules, 1992 & Odisha Sub-Ordinate Cooperative Service (Recruitment & Conditions of Service) Amendment Rules, 2011, written examinations will be conducted in General English, Arithmetic's and various working affairs/problems of Cooperative Institutions.

The Admit Card will be issued to the candidates before the date of the Examinations subject to the valid application after due verification and scrutiny.
